

**Town of Mount Airy  
Garbage Service**

- Town will provide one 95 gallon single rolling trash cart
- Pick-up every Thursday (have the cart out by 6 a.m.)
- Monthly charge of \$15.00 will appear on your water bill

**Change of Occupancy**

*Each Customer shall give not less than three (3) days notice in writing at the Town Hall to discontinue water and/or garbage service. The outgoing party shall be responsible for all water consumed up to the time of departure or the time specified for departure, whichever period is longer.*

*The new occupant shall apply for water and/or garbage within forty eight (48) hours after occupying the premises, and failure to do so shall make him liable for paying the water consumed and the garbage since the last meter reading.*

**Water/Fire/Garbage Department**

A person or entity seeking water/fire/land or garbage service from the Town of Mount Airy, shall complete an application in person at the Town Hall in Mount Airy, GA. A deposit shall be required for each as follows:

Type of Service	Deposit
Residential Home Owners:	100.00
Residential Renters:	100.00
Commercial Owners:	100.00
Commercial Renters:	100.00

*There is a fifty (\$50) non-refundable administration fee charged in addition to the security deposit.*

**Fire Protection \$8.00 per month**

*This information is printed in the Town of Mount Airy Water/Fire/Garbage Ordinance. A copy is on file and it can be purchased at Town Hall.*

**Tap Fees**

Meter installation for new service from the Town of Mount Airy shall pay a connecting or tap-on fee as follows:

- Inside Town limits: 3/4" \$1000.
- 1" \$1250.
- Outside Town limits: 3/4" \$1400.
- 1" \$1650.

**Responsibility for Leaks**

All leaks, which occur on the discharge side of the water meter, shall be the responsibility of the property owner.

It shall be the responsibility of the Water Department to maintain and repair the water line ending at the meter inlet coupling and the meter.

Customers or property owners shall be charged for water consumed due to any leak on the customer's side of the meter.

**Monthly Rates**

All water furnished by the Town of Mount Airy to Residential or Commercial users or Residential or Commercial property located within or without the corporate limits shall be metered and computed monthly and paid for at the following rates:

**Inside Town Limits:**

0-2000 Gallons	\$17.00
2001-10000	\$5 per thousand
10001 & over Gallons	\$8 per thousand

**Outside Town Limits:**

0-2000 Gallons	\$30.00
2001-10000	\$6 per thousand
10001 & over Gallons	\$10 per thousand

**Water Billing**

All water/and or fire protection/garbage bills are **DUE UPON RECEIPT**. Payments not received by the 10<sup>th</sup> are subject to a \$10.00 late penalty.

**Past Due Accounts**

Payments not received by the 20<sup>th</sup> of each month shall allow the Town, in addition to all other rights and remedies, to terminate agreement, and in such event, the water/ and or fire protection/garbage user shall not be entitled to receive, not the Town obligated to supply, water/ and or fire protection/garbage under the agreement. Services will be terminated without further notification.

Service terminated for non-payment of bill shall be restored only after payment of account is received. In full, such security deposit as may be required by the Mayor and City Council is made, and a reconnect fee paid of:

1. Twenty-Five Dollars (\$25.00) for the first time you are cut off
2. Seventy-Five Dollars (\$75.00) for the second time you are cut off

**Suspension of Service**

When water/and or fire protection/garbage service is discontinued and all bills are paid, the security deposit shall be refunded to the customer by the Town.

Upon discontinuance of service for non-payment of bills, the security deposit shall be applied by the Town of Mount Airy toward settlement of the account. The Town may proceed to collect any remaining balance in the usual way provided by law for collection for debts.
